

### **New Mexico vaccination rates**

- 76.4% of New Mexicans (18+) and 57.9% (12-17) have received at least a first dose
- 66.9% of New Mexicans (18+) and 45.0% (12-17) are fully vaccinated


### 6 days left for \$100 vaccine incentive!

- The last day to receive \$100 for getting vaccinated is Aug. 31
- First or second shot of Pfizer or Moderna – or a first-and-only shot of J&J
- 3<sup>rd</sup> dose shots are not eligible
- \$100 incentive available by email, text, or physical mail
- Email and text can only be spent online
- Physical mail can be spent anywhere, online or offline

- "I think this recent surge is mainly the delta variant," says Dr. David Scrase, at the press conference today.

- NMDOH urges healthcare providers caring for immunosuppressed patients to register with the agency as an approved COVID-19 vaccine provider: <u>TakeCareNM.org</u>

Active treatment for solid tumor and hematologic malignancies

Receipt of solid-organ transplant and taking immunosuppressive therapy

Receipt of CAR-T-cell or hematopoietic stem cell transplant (within 2 years of transplantation or taking immunosuppression therapy)

Moderate or severe primary immunodeficiency (e.g., DiGeorge syndrome, Wiskott-Aldrich syndrome)


Advanced or untreated HIV infection

Active treatment with high-dose corticosteroids (i.e., ≥20mg prednisone or equivalent per day), alkylating agents, antimetabolites, transplant-related immunosuppressive drugs, cancer chemotherapeutic agents classified as severely immunosuppressive, tumor-necrosis (TNF) blockers, and other biologic agents that are immunosuppressive or immunomodulatory.



# COVID-19 vaccine is safe in pregnancy and does not affect fertility

- Pregnant and recently pregnant people are more likely to get severely ill with COVID-19 compared to non-pregnant people
- Getting a COVID-19 vaccine can protect you from severe illness
- Vaccination Does not Affect Fertility

### Vaccine Recommended for people who are:

- Pregnant
- Breastfeeding
- Trying to get Pregnant
- Might become pregnant in the future

- Navajo Nation President
   Jonathan Nez announced new executive order on Sunday
- All Navajo Nation executive branch employees will need to be fully vaccinated against the virus that causes COVID-19 by the end of September or be required to submit to regular testing




"The bottom line is that we do not want to have another large surge in new COVID-19 cases that would harm our health care system and lead to more lives lost," President Nez said in a statement to AP.

# The majority of COVID-19 cases, hospitalizations, and deaths to date are among unvaccinated New Mexicans


Percent of New Mexico COVID-19 Cases, Hospitalizations, and Deaths by Vaccination Status

# COVID-19 infections, hospitalizations, and deaths are primarily among unvaccinated New Mexicans, but more vaccine-breakthrough cases are now occurring


Percent of New Mexico COVID-19 Cases, Hospitalizations, and Deaths by Vaccination Status

# The number of COVID-19 infections has recently surged among unvaccinated New Mexicans


7-day Rolling Average Case Rate (per 100,000 population) by Vaccination Status


### The number of hospitalizations has recently surged among unvaccinated New Mexicans

# In LA county, hospitalization rates among the unvaccinated were 29x greater than vaccinated

- During May 1-July 25, 2021, among 43,127 COVID-19 infections in residents of Los Angeles County, CA (Delta variant was predominant):
  - 10,895 (25.3%) in fully vaccinated persons,
  - 1,431 (3.3%) in partially vaccinated persons, and
  - 30,801 (71.4%) in unvaccinated persons.
- On July 25, infection and hospitalization rates among unvaccinated persons 4.9 and 29.2, respectively, times rate of fully vaccinated persons
- Fully vaccinated persons less likely than unvaccinated persons to be hospitalized, to be admitted to ICU, to require mechanical ventilation, or to die from SARS-CoV-2 during period when Delta variant became predominant
- Authorized vaccines protect against SARS-CoV-2 and severe COVID-19, even with increased community transmission of Delta variant




# COVID-19 vaccine effectiveness (VE) against infection has decreased over time, but continue to be highly effective at reducing risk of severe disease, hospitalization, and death

- NY State: age-adjusted VE against new COVID-19 diagnoses decline from 92% to 80%
  - Age-adjusted VE against hospitalizations remained stable at 92% to 95%
- Mayo Clinic: VE against Delta variant infection decreased for both mRNA vaccines (Pfizer: 76% to 42% and Moderna: 86% to 76%)
  - VE against hospitalization remained high
- Multiple other published studies now available demonstrating a decline in VE against infection




# Vaccine effectiveness against hospitalization remains high, data through July, 2021

In a MMWR evaluation at 21 hospitals in 18 states, the duration of mRNA vaccine effectiveness against COVID-19-associated hospitalizations was assessed among adults aged ≥ 18 years


#### 7-Day Average of Daily COVID-19 Positive Cases by Date of Specimen Collection, NMDOH Regions 8/25/2021





August 25, 2021




Southeast Region Case Count by Collection Date with 7-Day Moving Average







#### Staffed COVID ICU Beds




#### Staffed COVID Med/Surg Beds





### **New Mexico COVID Hospitalization Projections**





### Get tested for COVID-19 if...

#### ...you have COVID-19 symptoms

cough, fever, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell

...you don't have symptoms but were in close contact or are a household member of someone who has tested positive and are in their infectious period, regardless of vaccination status

...you don't have symptoms but are unvaccinated and live or work in a high-risk congregate setting such as long- term care facilities, detention centers and correctional facilities

...you are a patient scheduled for surgery or hospital admission, even if you're fully vaccinated. Some medical facilities may require testing prior to surgery or admission.





### State employee vaccination rates

- Vaccine is required for all state employees, or weekly testing
- Those who have been working with COVID since the beginning at the Department of Health have a very high vaccination rate
- If we could get all of NM to 85%, we could avert the coming hospital crisis
- If you choose not to be vaccinated, isolate and immediately seek treatment when you are infected




88% of NMDOH employees are fully vaccinated!

# Required vaccinations for healthcare workers

Most NM hospitals already require the following vaccines for healthcare workers (direct patient contact):

- Hepatitis B
- Influenza
- MMR
- Varicella
- Tdap
- Meningococcal



There were 687 cases among healthcare personnel for which the date was not known, therefore, those cases are not included in the figure above. There were 358 cases among healthcare personnel before March 1, 2020 not included in the figure above.

# Misinformation Moment: Unvaccinated couple dies of COVID-19 on same day

Martin and Trina Daniel (GA), married for over 20 years, both died of COVID-19 within hours of each other, leaving behind two teenage children facing an unimaginable loss.

Cornelius, Martin and Trina's nephew, told *ABC News*, "...I would prefer a vaccine over a ventilator every day. Too many families have already experienced the pain that we're feeling."

### End of federal unemployment programs

- All federal unemployment programs related to COVID-19 will end 9/4/21:
  - Sept 4<sup>th</sup>- Last day of federal extended benefits
  - Sept 5<sup>th</sup>- Last week for certification of federal extended benefits; waiting week reinstated for new claims
- NMDWS will ensure claimants waiting to receive eligibility determination will receive payments owed to them for all weeks prior to September 4 for which they certified and are determined eligible, even after federal programs end.

- 4 federal unemployment programs related to COVID-19 Pandemic
- PUA: Pandemic Unemployment Compensation
- FPUC: Federal Pandemic Unemployment Compensation
- PEUC/PEUC-A: Pandemic Emergency Unemployment Compensation
- MEUC: Mixed Earner Unemployment Compensation
